#### Preface

Over the past 70 years, the further development of industrialization and globalization has brought about a general improvement in global economic welfare. Meanwhile, it has also given rise to climate change, rich-poor disparities, biodiversity crisis and many other problems, which have urged countries all over the world to show concern for the sustainable development. At the World Economic Forum in Davos in 1999, former UN Secretary General Kofi Annan called on business leaders worldwide to follow the value criterion set together by all countries to achieve sound economic, social and environmental development. This call evolved into the Ten Principles of the UN Global Compact. The Ten Principles of the UN Global Compact have facilitated concerted action by multiple stakeholders, including business, public administration, intergovernmental organizations and non-governmental organizations, promoting effective cooperation in addressing common global issues.

The key to implementing the basic principles of the UN Global Compact and achieving healthy and sustainable development between economy, society and environment is to cultivate leaders with responsibility and leadership, amid which education being the fundamental matter. Therefore, Principles for Responsible Management Education (PRME) was proposed at the UN Global Compact Summit in Geneva in 2007, which advocates integrating the global value criterion of responsible management into the courses and scientific research in colleges and universities, encouraging responsible management education research worldwide, thus ensuring the social responsibility framework be fully understood and applied in future business management. Up till now, PRME has developed into an organizational relationship which links the United Nations and global business schools together.

The vision and mission of the PRME Initiative is to revolutionize the leading role of education, research and thinking in business management on a global scale. It aims to raise people's awareness of sustainable development as UN's goal and cultivate future business leaders with strong responsibility. PRME will move forward by implementing six principles in organizations that are close to their goals and capabilities.

The six principles are as follows. (1) The Purpose Principle. It aims to help students develop strong capacity and guide them to create sustainable business and social values in the future in order to better serve the inclusive and sustainable global economy. (2) The Values Principle. It aims to integrate the values of social responsibility put forward in international initiatives such as the UN Global Compact into academic courses and research. (3) The Method Principle. It aims to create educational systems, materials, procedures and environments that enable students to learn about responsibility and leadership effectively. (4) The Research Principle. It aims to encourage people to actively participate in theoretical and practical research to better understand enterprises' roles in creating sustainable social, environmental and economic value, the methods they use and the influence they have. (5) The Partnership Principle. It helps students have a deeper understanding of the challenges that business managers face in terms of social and environmental responsibility through communication and interaction. It also guides students to work with business managers to find the most effective way of addressing these challenges. (6) The Dialogue Principle. It aims to promote communication among teachers, students, businesses, governments, consumers, media, social organizations and other relevant interest groups and stakeholders on important issues such as global social responsibility and sustainable development. Under the framework of the six principles, universities that receive global recognition and participate in the PRME activities can show their counterparts all around the world how their students are cultivated. They can also share their innovative practice under the principle of responsible management education in terms of responsible leadership, entrepreneurship and innovation and cultural identity.

Since the responsible management education of business schools plays an important role in developing enterprises and society, PRME encourages business schools to place high emphasis on curriculum reform in the field of business ethics, business transparency and effective management and try to promote academic research and knowledge dissemination in business management in a responsible way. In addition, PRME encourages people to talk about business ethics and integrity of particular regions and industries in a specific context, providing an analytical tool for educators around the world. It is hoped that this will address the challenges of business ethics faced by students at work. Responsible management education is of vital importance in the cultivation of all-round talents with solid theoretical basis, rich knowledge and corporate social responsibility. Therefore, more than 860 higher education institutions worldwide that involve business and management have signed the PRME, including Cornell University, Oxford University, Tsinghua University, China Europe International Business School and other famous universities.

Over the past decade, colleges and universities in mainland China have been signing PRME principles. However, for a long time, there has not been a formal institutional organization in China to ensure regular communication with domestic institutions that are already in PRME or have the intention to join PRME, which is not in step with other countries and regions. In April 2021, with the support from the head and the secretariat of the UN Principles for Responsible Management Education, Prof. Huang Haifeng took the lead to set up the PRME China Academic Committee and PRME China Network. The preparatory work has received positive response from professors and scholars both at home and abroad. For example, Changzhou University, Xi'an Jiaotong-Liverpool University and Beijing Technology and Business University set up a working group within a short period of time, working in a collective response to hold the first conference of UN PRME China Academic Committee.

The establishment of PRME China Academic Committee as well as PRME China Network has received strong support from all walks of life. Dr. Mette Morsing, Global Head of Principles for Responsible Management Education, sent a congratulatory letter to offer praise and expectation for the preparatory work. Dr. Liu Jinghui, chairman of the Special Committee for Foreign Students of the Chinese Association for Higher Education, Senior Researcher of Taihe Think Tank and former Secretary General of China Scholarship Foundation, gave strong support and spoke highly of this conference, ready to attend it in Changzhou. Prof. Jiang Juncheng, President of Changzhou University, is now working together with all sectors to make full preparations for the conference. We would like to express our sincere gratitude for the high recognition and support from leaders of all sectors, which guarantees the successful establishment of PRME China Academic Committee and PRME China Network and safeguards the smoothness of the first conference of PRME China Academic Committee.

This conference has also gained recognition and support from some famous international scholars in the field of responsible management education, including Prof. MUNASINGHE Mohan, Co-Winner of the Nobel Prize, Visiting Professor of Peking University and Vice Chairman of the Intergovernmental Panel on Climate Change (IPCC-AR4); Prof. STAHL Gerhard, Former Secretary-General of the EU-Committee of the Regions, Visiting Professor of Peking University HSBC Business School and College of Europe as well as Member of the Scientific Board of FEP; Prof. Danica Purg, President of the Alliance of Management Development Associations for Global Growth Economies, the International Association for Management Development in Dynamic Societies (CEEMAN) and IEDC-Bled School of Management, Slovenia. They sent letters respectively to bless the conference a successful opening and express their best wishes for the bright future of China's responsible management education.

The conference also gets strong support from the cooperation partners, including colleges and universities, research institutes and media organizations that are committed to promoting the responsible management education.

#### Initiative

Chinese Initiatives to Promote Education for Ecological Civilization and the Implementation of the Principles of Responsible Management Education (PRME) The UNESCO World Conference on Education for Sustainable Development, 18-20 May 2021, made clear the need to integrate environmental education into all education sectors globally by 2025, and to systematically promote Education for Sustainable Development (ESD) in order to achieve the 2030 Agenda, the United Nations Agenda for Sustainable Development goals.

Achieving ecological civilization requires society as a whole to undergo a profound systemic change. Education is the deepest dynamic that can contribute to systemic change.

The core philosophy of Responsible and Sustainable Management Education (RSME) is dedicated to advancing the transformation of management and business education in higher education, reshaping business and management education into a sustainability-oriented, positive force for creating economic, social and environmental value, as a means of producing a new generation of business managers capable of taking on the complex and significant challenges of the 21st century.

By the end of May 2021, more than 860 higher education institutions from around the world (including some business and management education and training institutions) have signed up to the UN Global Compact Principles for Responsible Management Education (PRME) initiative to actively promote the integration of the Sustainable Development Goals into the business management education process based on the six PRME principles. Currently, only 19 university business schools in China have joined the UN Global Compact Principles for Responsible Management Education initiative. To a certain extent, this reflects the lack of understanding or/and attention to sustainable management education in business schools/business management schools in China's universities, and the lack of integration of sustainable development in the philosophy, direction and characteristics of schooling.

How China will achieve an ecological civilization and create a new business civilization in the future cannot be achieved without each and every one of us as researchers, communicators and practitioners. This is both the expectation of society and our unshirkable responsibility. We are willing to work together with our peers to promote the deep and long-term development of CSR and sustainability education in China! To this end, we sincerely urge all the members of the first PRME China Academic Committee, through you, to influence more business schools/management schools to actively join the UN Global Compact Principles for Responsible Management Education (PRME) initiative, and through this action network, to integrate the internationally advanced concepts of responsible and sustainable education into the education, research and social service practices of business schools in domestic universities, to enhance the interface with advanced business schools in the world, and to guide them to pay more attention to and think about the cross-linkages and innovation opportunities of sustainable development and management disciplines, and to foster competitive sustainable management talents for the post-2030 era! It also promotes the exchange between domestic business school students and international youth, directs them to pay more attention to and reflect on the cross-linkages and innovation opportunities between sustainability and management disciplines, and cultivates competitive sustainable management talents for the post-2030 era!


PRME Shows the Power and Wisdom of Chinese Ethics

has earned post-graduate degrees in engineering, physics & development economics from Cambridge University (UK), Massachusetts Inst. of Tech. (USA), and McGill and Concordia Universities (Canada), as well as several honorary doctorates (honoris causa).

Prof. Munasinghe is a leading expert on sustainable development, climate change, energy and environment, with worldwide field experience in disaster management, economics, environment, telecommunications, transport, urban infrastructure, and water resources projects. He has won many international awards and authored over 120 books and 450 papers. He is Fellow of several international Academies of Science, and editorial board member of over a dozen journals. He is Hon. Vice Patron of the Sri Lanka Tennis Association, and formerly represented Sri Lanka (Juniors) in tennis and won Sri Lanka National titles. His interests include swimming, wind surfing, chess, bridge, astronomy, saxophone, tai-chi, and meditation.

## Prof. Dr. Danica PURG (Slovenia)



President of the Alliance of Management Development Associations from Raising Economies, President of the International Association for Management Development in Dynamic Societies (CEEMAN), President of the IEDC-Bled School of Management, Slovenia. As an educator in the field of leadership arts, she has won important academic achievement awards from the United Nations, France and Slovenia, and has an important influence in the international education community.



## Prof. Gerhard STAHL (Germany)


#### Pro. Dr. Yi GUO

scientific research achievements. Her research interests include information management and intelligent logistics.




